<b>Masking Requirements in Clinical Areas</b> <i>Clinical areas are: buildings where clinical services are provided to patients, including hospitals, urgent care centers, and clinics.</i>	Always required for everyone	Always required for everyone	Required for everyone indoors Optional outdoors for vaccinated employees Discouraged indoor eating in patient care areas	Required for all unvaccinated individuals in all locations AND all employees, patients, and visitors in units caring for immunocompromised patients **

\*\* Individuals who are significantly immunocompromised should discuss appropriate PPE use, including masks, with their medical provider and may be advised to continue to wear a mask despite being fully vaccinated at all risk levels. Fully vaccinated, not immunosuppressed individuals may remove mask if alone in an enclosed room in an administrative area of a building.
